In addition, Zastrow also explained that social work as a profession has the main functions and duties to provide services in order to achieve people's social functioning through social interaction process.

"Social work is as leading profession in giving social services to help people, individually, in groups, family, as well as society, in solve social problems he faced. It is this responsibility that become the main mission of Social Worker. Mission Social Worker is not just help with troubleshooting, but also created conditions basic social support achievement of that goal. That matter Humans need to be able live life functionally in the face of social change this fast one." (Zastrow, 2004: 13) Moreover, in that reference other definitions are presented.

The National Association of Social Work (NASW) defines social work as professional activities help individuals, groups, or communities improve or restore their capacity to social function and create social conditions profitable for this purpose. Social work practice consists of professionals social application of work values, principles, and techniques for one or more to help people get real service (for example, involving providing food, housing, or income); provide counseling and psychotherapy with individuals, families and groups; help the community or group provide or improve services social and health; participate in relevant legislative process. NASW reports that Bob Etheridge (D-N.C.) as the representative of the people gave respect for social workers. She share with speakers from the US House of Representatives and comment as follows: "Social workers influence our lives in many ways. Their work touches us all as individuals and as a whole public. They are educated, highly trained, and committed professional, they work in family and health services mental community institutions, schools, hospitals, nursing homes, and more other private and public institutions. They listen, they care. And most importantly, they help those in need." (Vallianatos, 2012).

Currently in Indonesia it is estimated that there are more than 36,000 professional Social Workers graduates from 37 universities carry out job education Social/Social Welfare. Most of the of the number of professional Social Workers are members of the Workers' Association Indonesian Social Professionals (IPSPI). Lots of them work in Non-Governmental Organizations National Society (NGO) and International. Most of them work in Government Agencies and service institutions good social welfare belonging to the government and community (private).

Based on the Social Worker population data, It is also known that data up to May 2013 the number of Functional Social Workers 1,154 people who work in government agencies center and area. 2014 as many as 15.5 million families, while the current number of Social Workers is around 15,522 person. Thus it is still necessary around 139,000 Social Workers. Continuous need for social workers increased to deal with Persons Social Welfare Problems (PMKS) totaling 15.5 million households not balanced with college graduates social welfare and fans community to attend education work/social welfare, this is wrong One is because the community has not recognize social work as a profession that professional, people know better social work as a charity activity.

They are of the view that the field of this work can actually be done by anyone, not necessarily from graduates social work education. This is also what then can lead to quality service and problem solving become not optimal and achieve good results expected. This is explained on the P4S website Ministry of SoAffairs (accessed on October 1, 2014 at 14:07 WIB). In the situation and conditions of development social problems and public demands towards policy and program orientation social welfare development rests on justice for all and protect human rights when in the future, energy is needed social work professional.

If the Labor ratio Social Worker with people with at least one social welfare problem compared to 100, then the need for Workers Social media in Indonesia is at least as much as 155,000 people. Estimated number of PMKS per year this is meant for differentiate from those who work in social work but not come from graduate work education social. However, this is unavoidable because in reality many fields social work done by them who do not come from education graduates social work. Land that should be carried out by the social work profession will taken over by other professions.

The land in question is the realm of jobs that require expertise specific and can only be done by social worker. Many fields of work Social workers who are currently still being worked on other professions, such as psychologist, nursing and other professions. Social worker indeed profession that uses the heart, but the bill will strengthen the position of social workers professional and helpful as a form social work

practice accountability to the wider community. In some cases, we even find activists in the field of social work that is not comes from social work education successfully organized Activity 5% positions that can be applied by scholars from all majors.

There is already a law that require the Social Work profession to implement practices, such as (a) Law No. 11 2012 on the Criminal justice system Children who mandate assistance Social Worker for conflicted children with the law, (b) the Law on National Education System or better social services. Both conditions it further weakens existence social work as an area of expertise Specific.

Plus, at this time the social worker position can filled by all majors to enter CPNS in several provinces. Based on my opinion, This happened partly because of the absence of regulations that stipulate that the real work specifically can only be done by social workers cannot be handed over to by them who are not social workers. Based on the official website of KemenPAN-RB, There are 11 positions that can be applied for by Bachelors from all majors respectively agencies are, Policy Analysts, Planners, Auditor, Supervisory Organizing Affairs Local government, Self-Help Society, idyaiswara, researchers, workers social workers, social educators, engineers, and Examiner.

"For government agencies that haven't allocated formation for 11 positions that can be applied to by scholars from all the majors so that soon allocate it," said the Bureau Chief Law, Communication and Public Information Ministry of PANRB Herman Suryatman. But unfortunately, until now many central government agencies and areas that have not been allocated for regulation its derivatives expect work practices Social work in schools, (c) 19 aw No. 4 of 1997 concerning Persons with Disabilities, (d) Law No. 5 1997 concerning psychotropics; Law No. 13 2011 concerning the handling of the poor.

Administrators and people in power don't always have motivation or insight to initiate change that needed. Social workers should look at the environment to enforce the changes. The third dimension that makes unique social work related to environment.

mental targeting that is, workers social workers often feel the need to advocate for their clients. Defense actively intervene to help clients get what they need.

The most frequently, This intervention focuses on the "relationship between client and 'system' is unresponsive (Epstein, 1981, p. 8). The client has determined needs, and social institutions, organization. Unresponsive system must pressure to make changes so that needs can be met. The fourth dimension that makes unique social work is emphasis on and adherence to core professional values. NASW Code of Conduct focuses on the individual's right to make free choices and have quality of life (NASW, 1999). The employees Social media doesn't force a way of thinking or certain people act. Otherwise, they help people make own decisions about how to think or act.

The five dimensions make work unique social relationships with core values social work is how importance for clients in making their own decisions. The employees Social media doesn't track specific ways of thinking or act someone. Otherwise, they train in a partnership with clients, create and implement plan together. Most other professions emphasize authority and professional expertise, on one hand, and the client's subordinate status as service recipient.

EPA stated that "service, justice social status, dignity and worth of a person, the importance of human relations, integrity, competence, human rights, and scientific research is one of the values the core of social work" (CSWE, 2008b, Thing. 2).

The EPA also defines 10 regions who graduated from a social work program must have competence. Competence is "practical behavior" measurable knowledge which consists of sufficient, skills, and values, as well as have a purpose to practice effective. Competency 4: Diversity Engagement in Practical Diversity refers to different characteristics of people. The focus of the social work profession includes groups distinguished by "age, class, color, culture, disability, ethnicity, gender, gender identity and expression, immigration status, political ideology, race, religion, gender and sexual orientation" (CSWE, 2008b, p. 5). As for the four aspects main. First, social workers must respect differences and focus on strength. Fourth, social workers must look at themselves them as lifelong learners about many aspects of human diversity, especially the characteristics of the client.

Even prior to the COVID-19 pandemic, social workers were increasingly calling for and actively using information and communication technologies such as mobile text messaging interventions and digital momentary assessments in social work practice (Berzin et al., 2015). Harnessing technology for public good is one of the Grand Challenges for Social Work (Berzin et al., 2016). Yet, much of the concern regarding use of technology for social work has been focused on client privacy and the ethical ramifications of its use. Numerous articles have addressed the ethical concerns and competencies required to adequately implement social work interventions using tele-behavioral health (Berzin et al., 2015; Dombo et al., 2014; Mishna et al., 2014). The extent of tele-behavioral health use and training in social work prior to COVID-19 is relatively unknown. One study conducted in Israel found that only 4% of social workers had experience using electronic therapy (Cwikel & Friedmann, 2019). Although some social work scholars have suggested that there are likely low levels of telecommunication training in social work education programs (Berzin et al., 2015), as of 2017, 21 states included specific language on telehealth practice in social work scope-of-practice laws, suggesting that states have been moving to include this method as a standard practice (Page et al., 2017).

The COVID-19 pandemic fundamentally changed social work practice as hundreds of thousands of social workers had to quickly find ways to provide care despite shutdowns. Social workers have leaned on tele-behavioral health to ensure that clients have safe access to care during the pandemic. In this study, we sought to understand the extent to which social workers were able to provide tele-behavioral health services during the early pandemic and identify supports needed for social workers to continue this practice.
