In this case acting for and on behalf of OICA INDONESIA hereinafter referred to as the SECOND PARTY;

Under the terms of this agreement, agree to:

1. The Parties agree to enter into an MoU for academic exchange and standardization services;
2. The Parties recognize that the academic exchanges will promote educational collaboration and cultural understanding and have agreed to further continue their common interest in promoting the mutual cooperation in the area of education and research;

3. The Parties agree to implement the MOU under the terms and condition hereinafter set forth.

In practice, the activities generated under this agreement may include:

1. The Purpose of this Memorandum of Understanding is to make possible and to facilitate the early education (PAUD) education development, exchange of students, standardization services development, internship program to Japan, know how transfer of Japanese education, scholars and educational resources between Universitas Trilogi and OISCA College, based upon principles of mutual equality and the reciprocity of benefits;
2. The Objective of this MOU is strengthen ties between both parties and to promote academic cooperation and to further the understanding of the culture of the two countries concerned;

This agreement between two parties are in accordance with each responsibilities, functions and powers of each institution to implement their objectives consistent with developing further initiatives to realize the intentions behind this MOU.

Matters relating to the follow-up of this Memorandum of Understanding organized and implemented in a specific agreement that applies only with the consent of both parties and included in the agreement to be executed by an officer who was given the task/authorized by each party and is one integral part of this Memorandum of Cooperation.

This Memorandum of Cooperation is valid for a period 3 (three) years since signed and may be extended or terminated by consent of both parties.

The Memorandum of Cooperation was approved, prepared, signed in 2 (two) copies and sufficiently stamped held by each party and have the same legal force.
