# Memorandum of Understanding

PT. Six Capital Indonesia – A Registered Company &
Universitas TRILOGI – An Academic Institution

This Memorandum of Understanding ("MOU") is entered between

PT. Six Capital Indonesia ("Six Capital") a company incorporated in Indonesia, having its registered office represented by its undersigned of the ONE PART;

and

**Universitas TRILOGI** ("**TRILOGI**"), a Jakarta, Indonesia based institution of higher education represented by its undersigned of the OTHER PART.

Whereas SIX CAPITAL and TRILOGI shall be hereinafter jointly referred to as the "Parties" and individually as "Party."

#### Preamble

 The Parties enter into this MOU to build Six Capital's UTC – an R&D and Data Analytics Centre in TRILOGI with a core objective to impart a lifetime skill in Trading Financial Markets. SIX CAPITAL in partnership with its partners combines a pioneering trader insight training program with next generation alternative investment concepts that creates more empowering opportunities for aspiring traders and investors.

### Summary

- R&D and Data Analytics Centre is purely a skills development initiative and a Micro Learning program intended for students of TRILOGI to undergo a Foundation Course in Forex Trading and Vision Alpha (Trader Insight). This centre aims to expand TRILOGI's students' career options in different trading environments like Derivatives, Stocks, and Commodities Trading.
- 3. The Parties agree to bear their own costs of executing the said initiative.
- Top performing candidates from TRILOGI may be selected for further internship opportunities with SIX CAPITAL subject to candidates obtaining results that are satisfactory to SIX CAPITAL.

# **About Trader Insight Program**

5. Candidates enrolled under R&D and Data Analytics Centre – Trader Insight Program initially will take Micro Learning Course followed by Trader Insight session – in which the candidates

experience trading in live markets under a simulated environment utilizing proprietary software provided by SIX CAPITAL.

# **Key responsibilities of SIX CAPITAL**

- 6. Provide proprietary training material for the Micro Learning program.
- 7. Provide online guidance/mentoring for training.
- 8. Provide certification on completion of the training.
- 9. Use of Proprietary Software.

# Key responsibilities of TRILOGI

- Provide infrastructure equipped with Internet connections of sufficient speed to facilitate Micro Learning and use of Vision Alpha proprietary platform.
- 11. Initiate, promote and support the R&D and Data Analytics Centre Trader Insight Program to students of TRILOGI.
- 12. Encourage students to be active in Vision Alpha programme.
- 13. Provide manpower to co-ordinate the sessions.

### Miscellaneous

- 14. The Parties agree that there is no intention to create legal relations and the terms in this MOU are intended to guide the Parties in their non-binding obligations over the course of the next two (2) years, after which the Parties hereby express their intention to enter into definitive and legally binding agreements.
- 15. The Parties agree that they will not hold each other responsible for any losses incurred as a result of discontinuance of the R&D and Data Analytics Centre Vision Alpha Program.
- 16. Any dispute arising from the implementation of the provisions of this MOU shall be settled amicably by consultations or negotiations.
- 17. This MOU may be reviewed and amended at any time, by mutual written consent of the Parties.
- 18. The MOU shall be effective for a period of five (5) years and may be extended for the same period by mutual consent of the Parties.
- 19. Either Party may terminate this MOU by giving at least six months written notice to the other Party. The termination of this MOU shall not affect the validity and duration of any arrangements, programs, activities, or projects made under this MOU until the completion of such arrangements, programs, activities, or projects, unless otherwise agreed upon by the Parties.
